"Combatting Violence Against Children in Albania" Needs Assessment, Round table 26 March 2015, Tirana - International Hotel

The first Council of Europe Co-operation Document for Albania was approved by the Committee of Ministers in October 2012. In July 2014, the Committee of Ministers took note of the progress report on the implementation of the co-operation document, acknowledged the progress achieved and paved the way for the preparation of a new Programmatic Cooperation Document 2015 – 2017.

The round table in Albania will provide an opportunity for Albanian authorities, key stakeholders and Council of Europe to work together in identifying the country's needs to be addressed in order to strengthen the child protection system's capacity at national and local levels, to protect and promote children's rights, and to support the implementation of integrated strategies to protect children from violence as well as to ensure access to child-friendly services, in line with Council of Europe standards.

Objectives of the round table:

The key objective of the round table is to obtain an understanding of the strengths and weaknesses in the existing system of protection of children from violence in Albania, to identify the main needs and raise awareness on the Council of Europe standards in the three areas mentioned below:

(Session 1) Analyse the extent to which an integrated system for child protection has been implemented in Albania, in line with the recommendation of the Council of Europe. Identify the areas where priority intervention can be made and progress developed.

(Session 2) Present a model of an integrated approach for child protection against sexual violence and abuse, in line with the Council of Europe Convention for the Protection of children against sexual exploitation and sexual abuse. Identify the priority action that needs to be addressed, through prevention, protection of children, participation and prosecution of the perpetrator.

(Session 3) Raise awareness on the Council of Europe Guidelines on Child-friendly justice and identify the main gaps and needs in the country to improve children's access to justice (criminal, civil and administrative).

The final aim of the Roundtable will be to determine the needs for support to be provided to Albania, through the elaboration of a comprehensive project on Children's Rights for a duration of two years.
