Introduction: the Lanzarote Convention

- ✓ Unique among International Agreements
- ✓ Basic characteristics:
 - ✓ Comprehensive
 - ✓ In terms of scope
 - ✓ In terms of content
 - ✓ Child-friendly
 - ✓ Interdisciplinary/Multiagency
 - ✓ Proactive

General remarks

- ✓ Uniqueness of the Convention
- ✓ Drafted in 2007 and came into effect in 2010
- ✓ Signed by all 47 member states of CoE
- ✓ Ratified by 36 member states
- ✓ Open for accession to all non- member states of the CoE

Comprehensive

- ✓ In terms of definition as it addresses child sexual abuse and sexual exploitation in all their forms including:
 - sexual abuse within or outside of the family,
 child prostitution and pornography, solicitation
 (grooming) and corruption of children
- ✓ In terms of coverage:
 - Prevention, Protection, Prosecution

Child-friendly

The goal is to identify child-friendly strategies and practices to ensure:

✓ The "best interests of the child"

Whilst upholding the human right principle:

✓ The "due process" (fair trial)

Interdisciplinary; Multi-agency

- ✓ Proposes a holistic and non-fragmented approach by inter-sectoral coordination, agency cooperation and diversified professional collaboration in terms of:
 - Prevention
 - ✓ Protection by effective response, assessment and appropriate intervention
 - ✓ Investigation, Prosecution and Judgement

Proactive

✓ Identifies the infrastructure and legal provisions to ensure appropriate social protection from child sexual abuse and exploitation

As well as:

✓ Proposes principles that reflect dynamic implementation by articulated standard setting and strategies

The Lanzarote Committee: a dual role

✓ Monitoring

Ensure that all provisions of the Convention are enforced by identifying what works well and what hinders effective implementation.

✓ Observatory

- ✓ Facilitate the collection, analysis and exchange of information and best practices on legal, policy and technological developments
- ✓ General comments, proposals and opinions

Strategies of Monitoring

- ✓ General overview:
 - ✓ With regard to general legal and institutional framework and policies
- ✓ Thematic Monitoring
 - ✓ Procedure is divided by rounds, each round addresses a particular "theme"
- ✓ The first theme: "Sexual Abuse in the Circle of Trust"
