Six strategies to prevent and respond to violence against children

Strategy

Supporting parents, caregivers and families

<u>1</u>

Educating families, caregivers and parents on their child's early development increases the likelihood that they will use positive disciplining methods. This reduces the risk of violence within the home.

Strategy

2

Helping children and adolescents manage risks and challenges Giving children and adolescents the skills to cope and manage risks and challenges without the use of violence and to seek appropriate support when violence does occur is crucial for reducing violence in schools and communities.

3

Changing attitudes and social norms that encourage violence and discrimination

Changing the attitudes and social norms that hide violence in plain sight is the surest way to prevent violence from occurring in the first place.

4

Promoting and providing support services for children Encouraging children to seek quality professional support and report incidents of violence helps them to better cope with and resolve experiences of violence.

5

Implementing laws and policies that protect children Implementing and enforcing laws and policies that protect children sends a strong message to society that violence is unacceptable and will be punished.


Carrying out data collection and research

Knowing about violence – where it occurs, in what forms, and which age groups and communities of children are most affected – is essential to planning and designing intervention strategies, and setting numerical and time-bound targets to monitor progress and end violence.

Findings and Lessons Learned

- ➤ To create an empowering, inclusive and safe digital environment for all children, we need to **strike a balance** between ensuring that all children have **equal access**, and may take advantage of the benefits offered by ICTs, at the same time as **minimizing risks and potential harm** from using ICTs.
- What happens in the online environment is a reflection of society at large, and of the dangers that children face in their homes, schools, communities and in institutions that ought to be protective.
- Strategies to address online-related violence and exploitation, must therefore be integrated into wider protection strategies to address other violence, abuse and exploitation taking place through other modalities.

MULTI-STAKEHOLDER APPROACH

To effectively protect children from harm when using ICTs, a range of stakeholders need to take action

- Governments, parliamentarians, civil society, the private sector, professionals working with and for children, teachers, parents, children, media, academia, and the private sector, all have a role to play.
- Guidelines for Industry on Child Online Protection – ITU, UNICEF and partners
- Multi-stakeholder roundtables at country level convening different stakeholders – government, industry and NGOs


INTERNATIONAL COLLABORATION



- Cooperation and coordination among different stakeholders is not only critical at national level but essential at international level.
- ➤ The #We PROTECT Children Online Summit and the Global Alliance against Child Abuse Online, represent important efforts to foster international cooperation and create a global alliance to address online child sexual exploitation.
- Global programme to build capacity to tackle online sexual exploitation, in an estimated 17 countries across six regions and with regional level engagement and activities at global level by UNICEF and partners
- ➤ Important contribution to scale up much needed actions to address violence against children, including online child sexual exploitation

ITU CHILD ONLINE PROTECTION INITIATIVE

- Established by the International Telecommunication Union (ITU) in 2008
- The initiative works to establish an international collaborative network for promoting child online protection through information sharing, providing guidance and best practices on safe online behavior, and helping partners develop and implement effective plans.
- It brings together partners from all sectors of the global community to ensure a safe and secure online experience for children everywhere
