Steven Allen

Steven Allen is UNICEF Regional Director for Central and Eastern Europe and the Commonwealth of Independent States since April 2009. Based in Geneva, he leads UNICEF's work in Eastern Europe, the Caucasus and Central Asia. Prior to this, he was Director of Human Resources in UNICEF New York Headquarters from 2004 to 2009, and UNICEF Representative in Indonesia from 2002 to 2004. From 1998 to 2002 Mr Allen was UNICEF Special Representative for the Balkans, where he led UNICEF's advocacy and programmes in South East Europe. Concurrently he served as UN Humanitarian Coordinator in Belgrade from 1999 to 2002.

Mr Allen joined UNICEF in 1977 and worked in Sudan, Myanmar, Vietnam and Pakistan, Iraq, the Democratic Republic of the Congo and Rwanda until 1998. He worked with OXFAM in Ethiopia in 1974 and with UNDP and WFP in Sudan from 1975 to 1977.

Mr Allen is a national of the United Kingdom. He holds a Bachelor of Science Degree in Economics and Politics from the London School of Economics, and Master of Science Degree in Medical Demography from the London School of Hygiene and Tropical Medicine.

She was a member of a number of government advisory groups.

*She created and directed the EU transnational network project, **Parenting in Europe in the 21st Century**, linking organisations working with parents in eight countries across Europe. She is a member of the Council of the Fédération Internationale pour l'Education des Parents and of The Vienna Committee for the Family. She has taken part in numerous TV and radio broadcasts most recently a programme on absent fathers broadcast in September 09 by BBC.*

In 2000, Mary was awarded the MBE for services to parenting education and family learning and in 2008 the OBE for services to children and families. She regularly speaks at conferences throughout the UK and Europe and has also been invited to speak in Australia and the US.

Maria Herczog

Maria Herczog is a Ph.D. in Sociology, MA in Economics, Reader and senior researcher at Eszterházy Károly College, president of Eurochild and chair of the Family Child Youth Association (<http://www.csagyi.hu/en/association>). Her main area of research is child welfare and child protection.

Since 1992 she has been the chief editor of the only Hungarian professional journal "Family, Child, Youth" (www.csagyi.hu). She has been working with different international organisations – Council of Europe, UNICEF, WHO - as a temporary scientific expert and consultant. She was one of the civil representatives in the European Economic and Social Committee between 2004-2010.

She has been Researcher and Project Manager at the Institute for Human Rights/Department of Law - Åbo Akademi University and lecturer of international law for the Foreign Service Programme of the University of Oxford. She is the author of a large number of publications on human rights protection and the legal status of the OSCE.

Marek Michalak

Marek Michalak was born on the 27th of July 1971 in Świdnica, Poland. He is a graduate of Rehabilitation Pedagogy and also postgraduate studies in the field of Socioterapy and Organization of Social Aid.

He has begun his social work already as a teenager. In 1987 he was appointed President of an organization helping children with diseases "SERCE" in Świdnica and three years later became President of the Board of the organization "SERCE". He was also a member and founder of a National Forum for Children Rights.

Marek Michalak was a founder of „The European Centre for Children's Friendship" which programme dedicated to helping child and family has been awarded many times. "The Centre" was described by the Polish Foundation for Children and Adolescents as one of the best preventive and development projects in the country.

In 1994 Marek Michalak was awarded with the Order of Smile. He sits on an International Chapter of the Order; first acted as its Vice-Chancellor and after January 2007 as the Chancellor.

On the 25th of July 2008 he was appointed as the Ombudsman for Children of the Republic of Poland.

Since September 2011 he has been a Chair of the European Network of Ombudspersons for Children ENOC.

Child psychiatrist

Born in Marseille

Studied medicine in Marseille, then specialised in psychiatry and child psychiatry at Nice University Hospital.

Has worked as a psychiatrist (with a psychoanalytical orientation) in various institutions, in the adult psychiatry and school psychiatry departments of the city of Nice, and as head of a day hospital.

Seconded from the university child psychiatry department of Lenval Hospital to participate in the setting up of the Medico-psychological Centre in Monaco, which is open to children up to the age of 18 who are nationals of the Principality or attending school there.

Attaches great importance to multidisciplinary teamwork.

Also has a private practice.

Peter Newell

Peter Newell works as an advocate for children's rights, in the UK and internationally. He is Coordinator of the Global Initiative to End All Corporal Punishment of Children, chairs the Council of the Child Rights International Network and, is Vice-President of the NGO Group for the Convention on the Rights of the Child. Together with Rachel Hodgkin, he has prepared successive editions of UNICEF's Implementation Handbook for the Convention on the Rights of the Child. Peter is Hon. Adviser to ENOC, the European Network of Ombudspersons for Children. He has been involved in use of the European Court of Human Rights and the collective complaints procedure under the Social Charter to pursue children's rights violations.

Jean-Philippe Noat

Jean-Philippe NOAT, technical director of Action Innocence, is a computer scientist in charge of dealing with cybercrime cases in Monaco. He also heads an information technology company in Monaco. As child protection on the Internet is one of his priority concerns, he joined with a few friends in 2003 in producing the first software program to counter Internet child pornography (logp2p), which they have since further developed. The principle of the software, which is currently used by many police forces in Europe, led to the arrest in 2010 of over 2 500 alleged paedophiles and, above all, to the identification of over 50 abused children and almost 40 large-scale producers of paedophile

material. At the same time, he is seeking on a technical level to increase co-operation between European police forces through a Monaco-based forum and dedicated website containing almost 10 000 articles which are consulted by almost 250 specialist police officers. The website is being expanded with fresh feedback every day and is a real professional database for its members. He has been co-operating with the Monegasque police and justice system for over seven years.

Theo Noten

Theo Noten is since 1996 managing ECPAT Netherlands and has since 1998 a governing position in Meldpunt Kinderporno, the Dutch Hotline on child pornography in the Internet, member of INHOPE (International Association of Internet Hotlines). Meldpunt Kinderporno is since 1999 involved in a surfsafe campaign giving tips to children and since 2008 providing a hotline to children and young people victims of sexual abuse and exploitation online. He is involved in the Dutch multistakeholder platform on child safety online since 2008.

He is a member of the executive board of ECPAT International since 2005 and advisory on trafficking, child pornography and child sex tourism issues. He has contributed to ECPAT International publications like Violence against Children in Cyberspace. He was in the ECPAT International preparatory team for the Council of Europe Convention against sexual abuse and sexual exploitation of children (2006-2007) and for World Congress III against the sexual exploitation of children and adolescents (2008). Since 2008 he is involved in eNACSO, the European NGO Alliance on Child Safety Online. He has contributed to the development of the EU Directive against sexual abuse, sexual exploitation of children and child pornography. He is in the International NGO Advisory Council for the follow up of the UN Study on Violence against children since 2007, representing ECPAT International. He is partner in the ECPAT –The Body Shop campaign STOP sex trafficking in children and young people.

Stefan Oeter

Full Professor for German and Comparative Public Law and Public International Law, Managing Director of the Institute of International Affairs, University of Hamburg Law School (since 1999); studied law at the universities of Heidelberg and Montpellier; 1987-1997 research fellow at the Max Planck Institute for Comparative Public and Public International Law, Heidelberg; 1990 Dr. iur. utr. (Heidelberg); Chairman (since 2006) of the Independent Committee of Experts of the European Charter for Regional or Minority Languages (Council of Europe); Member of the Scientific Advisory Board of the Federal Ministry of Transport; President of the Historical Commission, International Society for Military Law and the Laws of War; Member of the Permanent Court of Arbitration; research mainly in comparative federalism, minority protection and human rights law, humanitarian law, European and international economic law, theory of international law and international relations.

Jenny Pearce

Jenny Pearce is Professor of Young People and Public Policy at the University of Bedfordshire, UK, where she is Director of the 'International Centre for the Study of Sexually Exploited and Trafficked Young People' and the 'Institute of Applied Social Research'. She is Chair of the UK Home Office 'Child Trafficking Information Sharing Forum' and co-founder and management group member of the 'National Working Group for Sexually Exploited Children and Young People' (www.nationalworkinggroup.co.uk). She runs a 'Child Sexual Exploitation' research forum in partnership with Barnardo's Children's Charity and is a member of the Policy Steering Committee of 'Eurochild', Brussels. She has researched and published on a number of topics related to child protection, child sexual exploitation and child trafficking. She is currently developing the 'Our Voices' Project: a European network of projects challenging sexual violence against children. She works with the Council of Europe as an invited expert on child sexual exploitation.

Jenny Pearce trained as a teacher, and has worked in schools, youth justice and youth and community work. She works in partnership with young people, NGOs and statutory services in Europe to develop opportunities for training, research and curriculum development on child welfare and child protection.

Paulo Sérgio Pinheiro

Pinheiro is Adjunct Professor of international relations at the Watson Institute of International Studies, Brown University. He is research coordinator at the Center for the Study of Violence, and Professor of Political Science (retired) at the University of São Paulo, USP, and Brazil. He has also taught at Columbia University, Notre Dame University, Oxford and the École des hautes études en sciences sociales, Paris. He is a Commissioner and Rapporteur on Children, Inter-American Commission on Human Rights, IACHR, Organization of America States, OAS, and Washington.

In 2003 Pinheiro was appointed by the UN Secretary-General as Independent Expert, to prepare a study in depth on violence against children and he visited 45 countries. He presented the World Report on Violence against Children, 2006 and has followed up the recommendations of the report during 2007.

Pinheiro served as Secretary of State for Human Rights, under President Cardoso, Brazil, and as Rapporteur of the Brazilian government National Human Rights Plans, PNDH I, 1996 and PNDH II, 2002. Under President Lula, he was an expert for the preparation of the PNDH 3, 2009 and he has been appointed by the President to represent civil society at the six members' inter-ministerial working group to prepare a Truth Commission in Brazil, 2010.

Georg Pirker

As of 2007, Georg Pirker is elected secretary of the DARE network (the European network for Democracy and Human Rights Education with 50 member organizations from 28 countries) and represents DARE's view in various political bodies on European level. Further he is the person responsible for the department of European and international educational work at AdB (Association of German educational organizations) an umbrella organization of civic educational NGO's in Germany. He is an expert for non-formal Education for Democratic Citizenship and Human Rights Education in both adult and youth learning in Europe and supervises the international work of about 180 German educational centres.
