

## Highlights of the January 2007 part-session

- ▶ **22 January:** Chris Green, Manager of the White Ribbon Campaign (UK) is meeting parliamentarians in Strasbourg (information stand, 1 p.m.-2 p.m.). Chris Green will meet parliamentarians on the issue of the role of men in combating domestic violence against women and the White Ribbon Campaign in the United Kingdom during the part-session. As a member of the Council of Europe Task Force, he will also participate in an exchange of views with members of the Equality Committee on the same day.
- ▶ **23 January:** Projection of the Swiss documentary "Seules avec nos histoires" in partnership with ARTE (1 p.m., projection room of the Council of Europe – in French and German) followed by an exchange of views at 1.40 p.m. with a representative of ARTE on how medias and MPs can work together to raise awareness on the issue of combating domestic violence.
- ▶ **22-26 January:** PACE information stand on the Assembly action "parliaments united in combating domestic violence" near the hemicycle.

### Parliaments united in combating domestic violence against women

The contact parliamentarians appointed by national parliaments are mobilised to contribute to the Campaign to combat domestic violence against women at parliamentary level. The network of parliamentarians first met in Strasbourg on 19 October 2006. To date, 40 contact parliamentarians have been appointed, including by the European Parliament and the Nordic Council.

### Successful launching of the Campaign in the Spanish Senate on 27 November 2006



"Whether we are national, regional or local elected representatives or simple citizens, domestic violence against women is a problem that concerns us all. It is our individual and collective responsibility to break the silence and take action", Council of Europe Parliamentary Assembly (PACE) President René van der Linden said in Madrid at the launching of the Council of Europe Campaign to combat domestic violence. The launching conference was a great success with 400 participants and benefited from large media coverage. Spanish Prime Minister José Luis Rodríguez Zapatero and the Secretary General of the Council of Europe, Terry Davis, participated in the launching ceremony among other high ranking personalities.

Excerpt from the interview with Mr Mendes Bota, contact parliamentarian for Portugal, on the role of men in combating domestic violence (available on the website [www.coe.int/stopviolence/assembly](http://www.coe.int/stopviolence/assembly))

“Men still have a lot of prejudices about questions relating to women’s emancipation and equal opportunities. The image of the committees and organisations in which practically no one but women are seen really does not assist in breaking down this barrier. There should be more men participating in these organisations so that people stop thinking these subjects can be handled only by women. (...) Men are the protagonists of a paternalistic, male-centred society which perceives women as inferior, submissive beings with secondary status in power relationships. It is important that men appear in the vanguard, precisely in order to tell other men that the path leading to domestic violence is not the right one and constitutes a violation of human rights.”



## A new pan-European initiative in support of the Campaign: Day of Parliamentary Hearings

The Parliamentary Assembly’s Committee on Equal Opportunities for Women and Men is proposing a new high-profile initiative by parliaments in conjunction with International Women’s Day.

National parliaments are invited to organise a Day of Parliamentary Hearings, in conjunction with International Women’s Day on 8 March 2007, to say “Stop domestic violence against women”.

These hearings will be the opportunity to bring together all the players involved in combating violence against women and to take stock of national legislation. Parliaments are invited to associate government representatives and local and regional elected officials, professionals working with the victims (police, courts, social and educational services, medical services, etc.) and NGOs involved in defending human rights and protecting women who are victims of domestic violence. These hearings could be organised by Committees on Equal Opportunities, Committees on Human Rights or specialised sub-committees. Films, talks, exhibitions and any other high-profile initiatives members of parliament can imagine could also be organised on this Day of Action.

In March 2007, the parliaments of Europe will be uniting to provide a forum for the victims of domestic violence and those involved in combating it. I call on all our colleagues to join with the contact parliamentarians in contributing to this Pan-European Day of Parliamentary Hearings and, in so doing, break the law of silence.
