## RIA Novosti Journalist Kyrylo Vyshynsky Held on Treason Allegations in Ukraine

Kyrylo Vyshynsky, a Ukrainian journalist working for Russia's state-run news agency RIA Novosti in the Ukrainian capital Kyiv, was detained on 15 May 2018 on allegations of treason. His arrest came hours before raids by Ukrainian security service (SBU) at the news agency's offices. According to media reports, the authorities suspected Vyshynsky, who was granted Russian citizenship in 2015 by Presidential decree, of allegedly collaborating with Ukrainian armed separatists in Eastern Ukraine. The prosecuting officials in Kyiv also accused him of allegedly subversive reporting to justify Moscow's annexation of Crimea in 2014, media reports added. 51-year-old Vyshynsky joined RIA Novosti in 2015 after having worked for several Ukrainian media outlets and Russia's state television channel Rossiya as its correspondent in Kyiv.

### UPDATES

**NEW** **24 Jul 2019:** On 7 May 2019, a district court in Kiev extended Vyshynsky's arrest till 22 July 2019. On 19 July 2019, Kyrylo Vyshynsky, appeared in court in Kyiv. The Court extended his pretrial custody by two months, to 19 September.

**12 Apr 2019:** On 4 April 2019, the trial against Kyrylo Vyshynsky began in Kyiv's Podil District Court. Mr Vyshynsky faces up to 15 years in prison, if found guilty of treason charges against him.

**14 Feb 2019:** On 8 February 2019, the court in Kherson extended until 8 April 2019 the arrest of Kyrylo Vyshynsky.

**17 May 2018:** On 17 May 2018, a court ordered Kyrylo Vyshynsky held for two months detention on high treason charges.
