Mayor Metshin became a member of the Working Group of Local and Regional Leaders (Working Group of Post- 2015), which was created to form a common position among local authorities towards the development agenda of the international community after 2015.

On April 23, the UCLG and Mayor Metshin initiated a meeting with United Nations Secretary-General, Ban Ki-Moon, and members of the UCLG in New York during which they developed ideas and recommendations aimed at the sustainable development of certain cities and regions.

In 2011, Mayor of Istanbul, Kadir Topbaş, was elected president of the World Organization of UCLG led with strong support from Mayor Metshin and the other mayors of Eurasia. Currently, Kazan has 15 sister cities, and 9 foreign partners. The mayor personally controls their interaction, meeting the official delegation, paying visits to share experiences and to consider further possibilities of mutually beneficial partnerships.

Ilsur Metshin has been re-elected to the post of Mayor of Kazan three times and consistently takes 1st place in the ranking of Russian mayors.

Mayor Metshin is considered to be an authority in the international arena for promoting the involvement of a great number of Russian cities in the Euro-Asia section of the World Organization of UCLG, and initiating the development of an international ranking of cities in Russia. In addition, he made a significant personal contribution to Kazan winning the campaign to host the XXVII World Summer Universiade 2013.

In 2011, Kazan won the right to host the 16th FINA World Championships with significant efforts from Mayor Metshin. In 2015, Kazan won the right to host the World Championship for Trades- the "World Skills Competition- 2019".

Kazan was awarded the commendation of "Highly Recommended Sport City", meaning that it was acknowledged as the best place in the world for hosting international sporting events. It received the most prestigious international award for achievements in the field of sports management "International Sports Event Management Awards- 2013" for its success in hosting the XXVII World Summer Universiade 2013.

The Mayor of Kazan was unanimously elected president of the football club "Rubin" in 2015.

Mayor Metshin worked daily at full capacity to monitor the progress on every detail regarding the championships. He worked as the deputy chairman of the Republican Organizing Committee and tackled arising issues. He headed the working group responsible for preparing the urban infrastructure, and the opening and closing ceremonies XVI FINA World Championships 2015 in Kazan and 16th FINA World Championships in the category of "Masters".

Numerous ratings show success and the positive dynamics of the development of Kazan. According to the Financial University under the Government of the Russian Federation, Kazan takes 3rd place in the list of Russian cities with the best quality of life.

In the ranking of investment cities, Kazan takes 4th place in country. Based on the sporting skills of a city and the number of major sporting events which are held there, the international "Ultimate Sports Cities" ranking included Kazan into their top 30 cities in the world.
