BACKGROUND AND JUSTIFICATION

The promotion of equality of rights and opportunities between women and men, and promotion of children's rights are core European values, and are enshrined in a number of formal commitments. Ukraine has signed most international agreements in this area, which are also supported by the EU and ratified by all Member States. This set of conventions and treaties constitutes the framework of reference for any future work on women's and children's rights, and will provide the direction for any legislative approximation work, as well as for enforcement efforts. Major studies and surveys led by other donors in the past ten years, as well as a number of small-size projects, have developed a solid basis of knowledge on existing gaps.

Article 24 of the Ukrainian *Constitution* guarantees equal rights for women and men, as well as the right for women to combine work and motherhood. In addition, Ukraine has signed all major international conventions on women's and children's rights. A large enforcement gap, however, remains to be closed between legal and constitutional commitments on the one hand, and daily life of women and children on the other hand. Since January 2005, this discrepancy has increasingly been acknowledged by the Government of Ukraine.

One of the main objectives of the proposed project is to undertake a strategic approach and detailed mapping of the problems and needs relating to women's and children's rights that will have to be addressed in order for Ukraine to be able to meet its obligations under the relevant international instruments. The project addresses a range of needs, in particular need to address issues of gender equality and Social Charter (non-discrimination, violence against women), the protection of children's rights (child labour, ill-treatment and abuse of children), the protection of children, including from trafficking and sexual exploitation.

PURPOSES, OUTPUTS AND ACTIVITIES

Objective	The objective of the project is to examine and improve the compatibility of existing laws and practice in Ukraine in the fields of gender equality and children's rights, and to contribute to the prevention of sexual exploitation and abuse of children in line with the Revised Social Charter, the Council of Europe Convention on the Protection of Children against Sexual Exploitation and Sexual Abuse, and other relevant European and international instruments.

Activity 4.6	Provision of 2 legal training and drafting workshops on the application of international standards related to the <i>Investigation, Prosecution and Criminal Procedure Law</i> and introduction of recommendations for improvement
Activity 4.7	Provision of one multidisciplinary workshop on <i>specialised and coordinating bodies, and Intervention Programmes and Measures</i> aimed at protection and prevention of children being sexually exploited and abused and introduction of recommendations for improvement
Activity 4.8	Seminar on legal cross-cutting issues related to the nexus between Cybercrime and child pornography for the purposes of sexual exploitation and abuse
