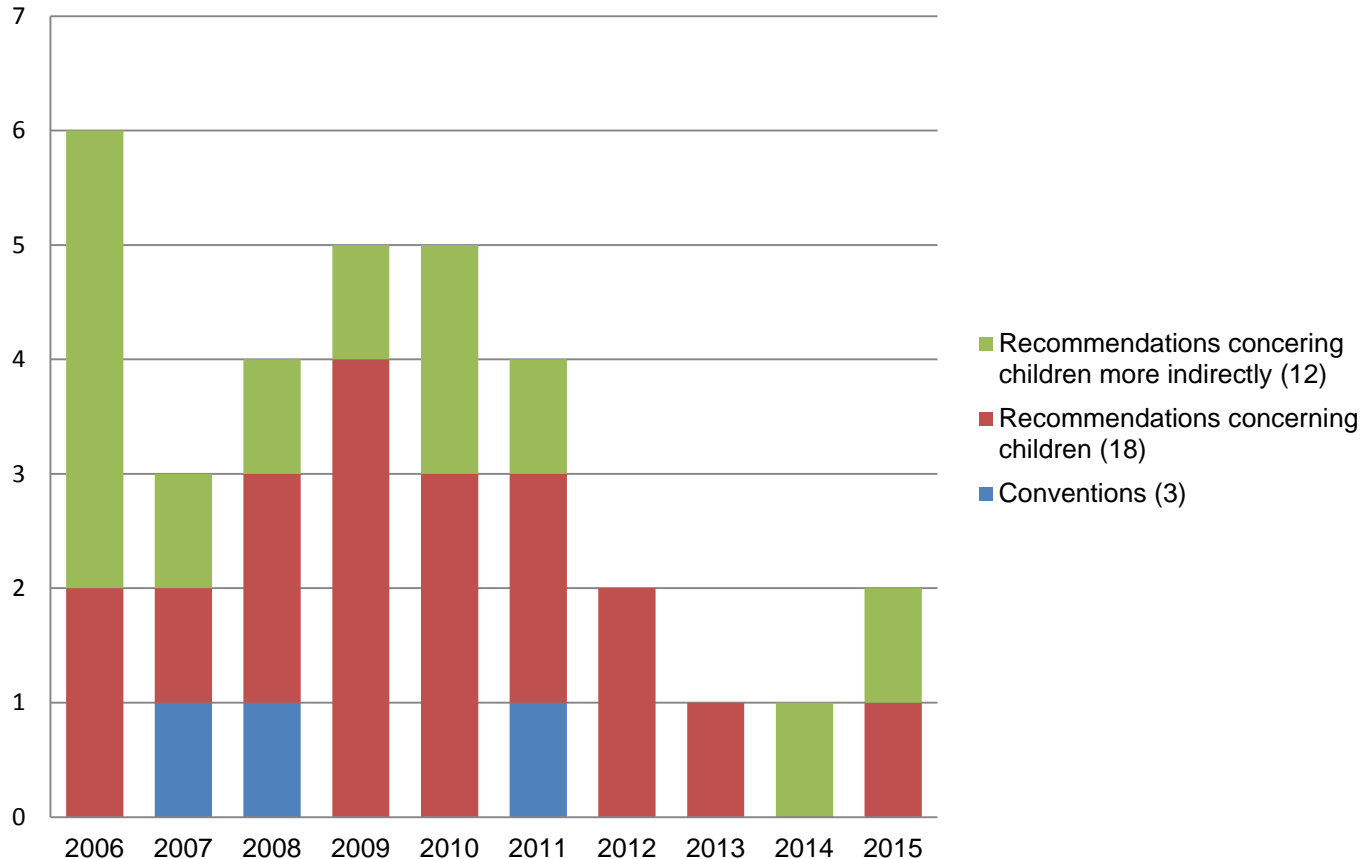

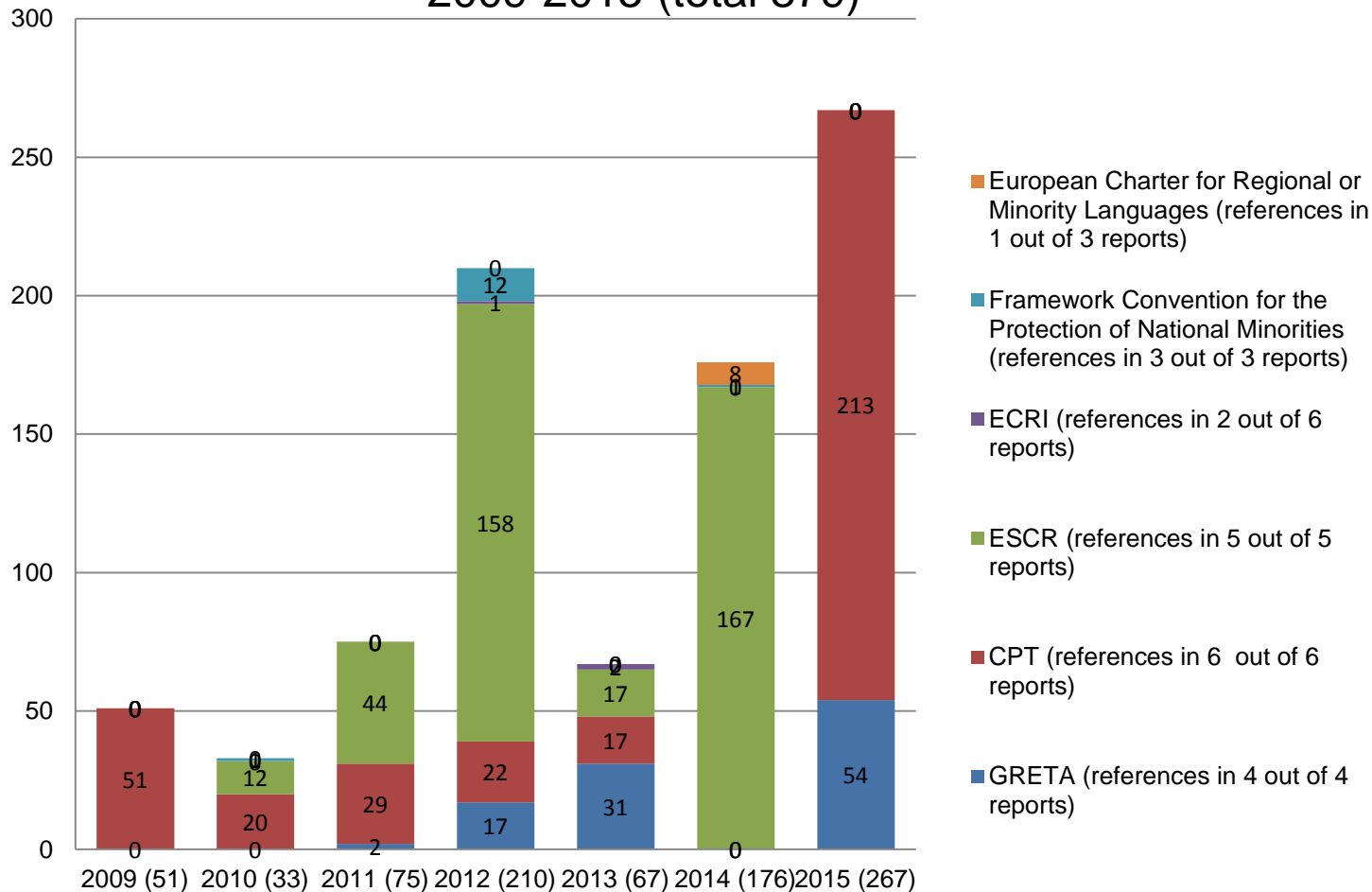
Legal standards adopted by the

2009-2015 (total 879)

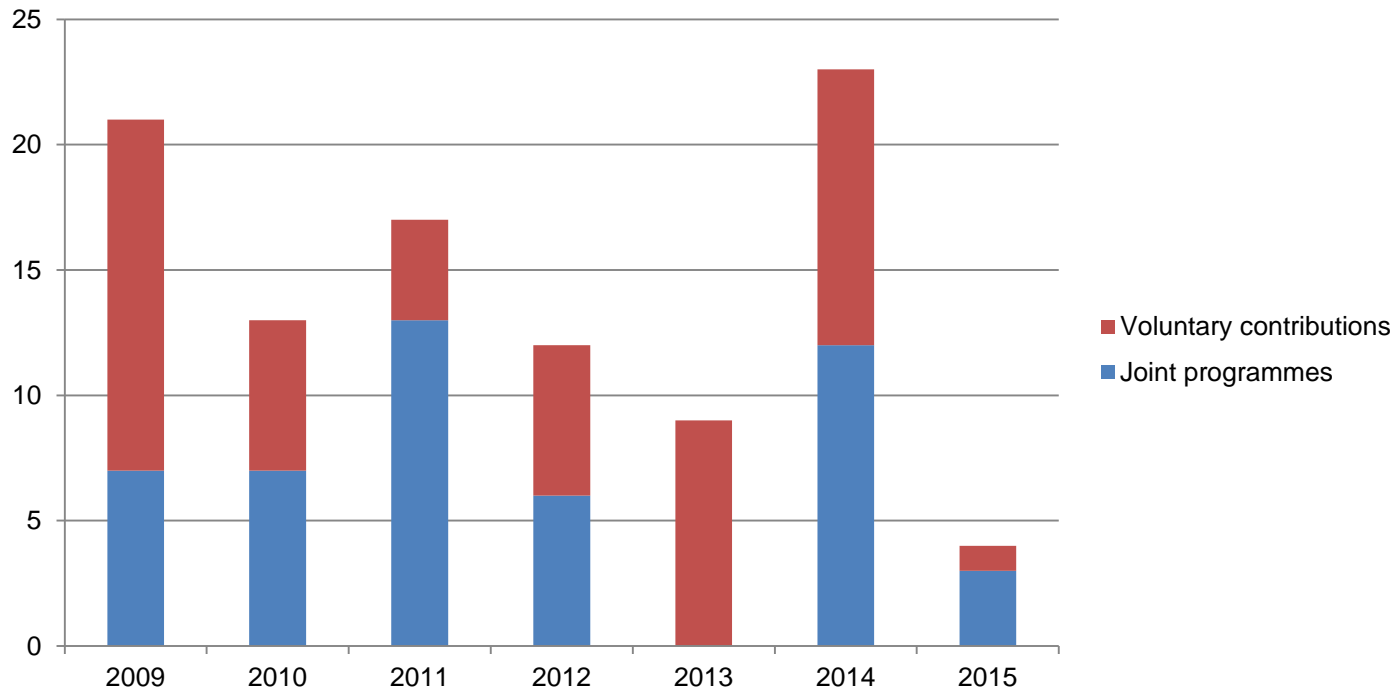

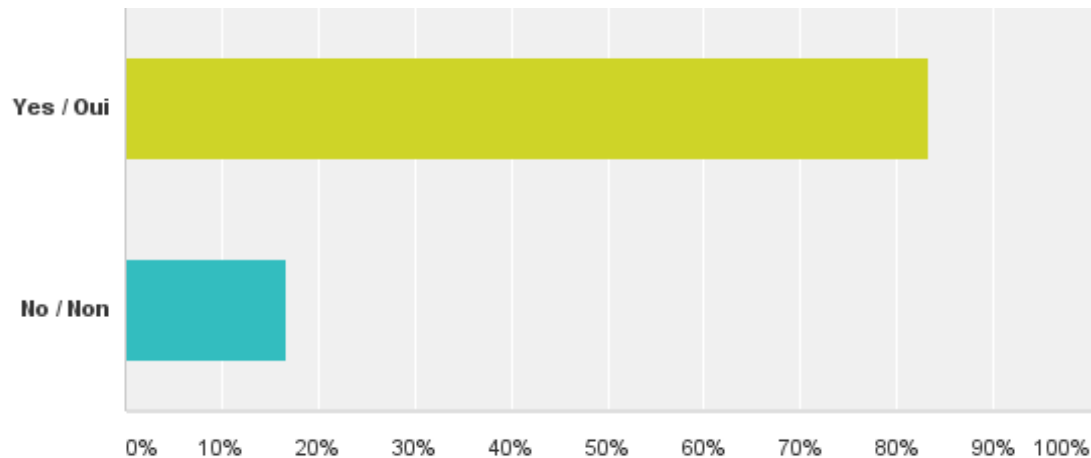

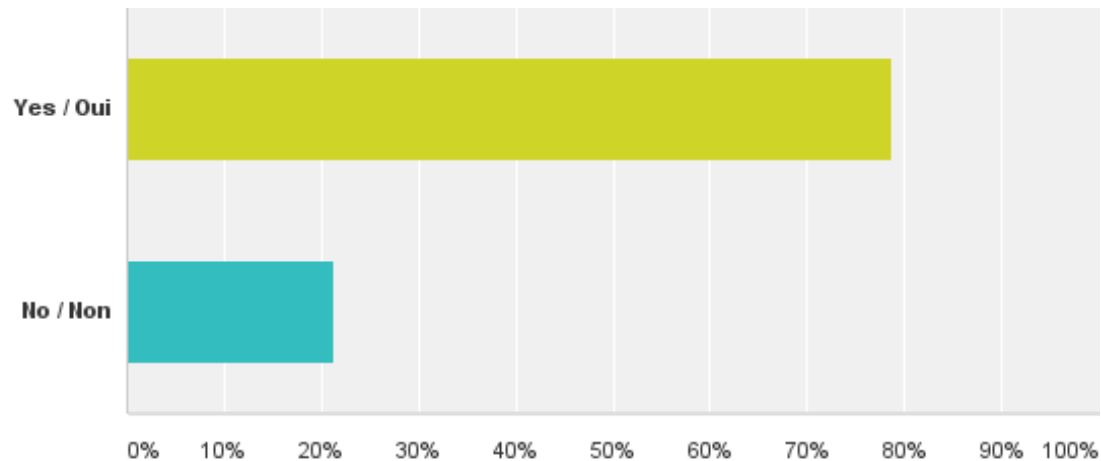

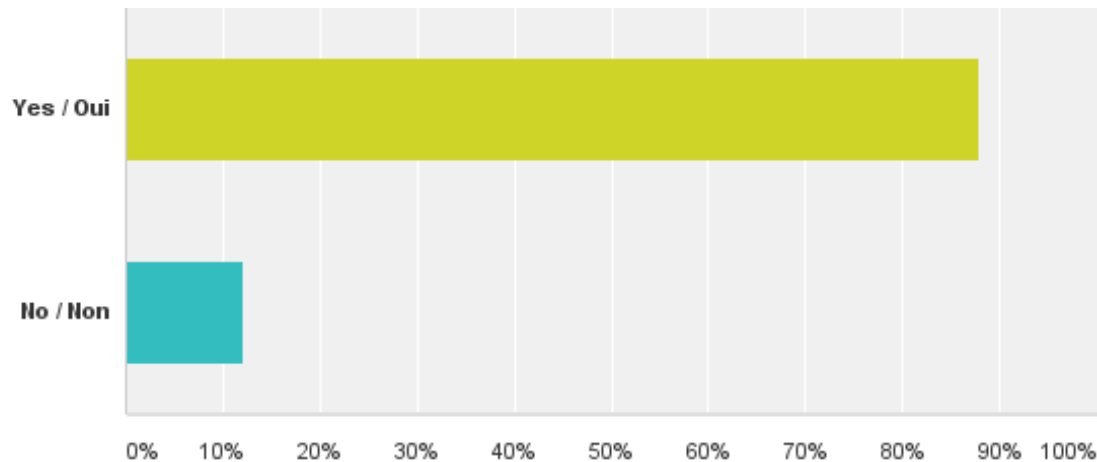

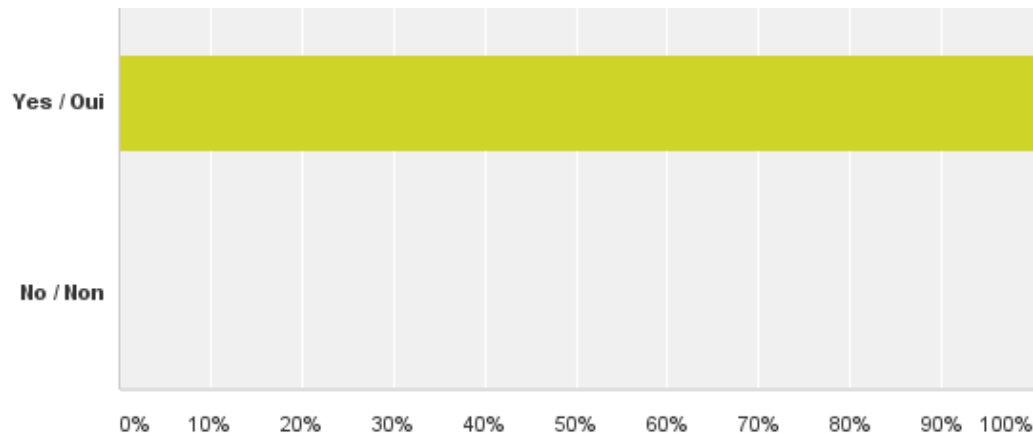

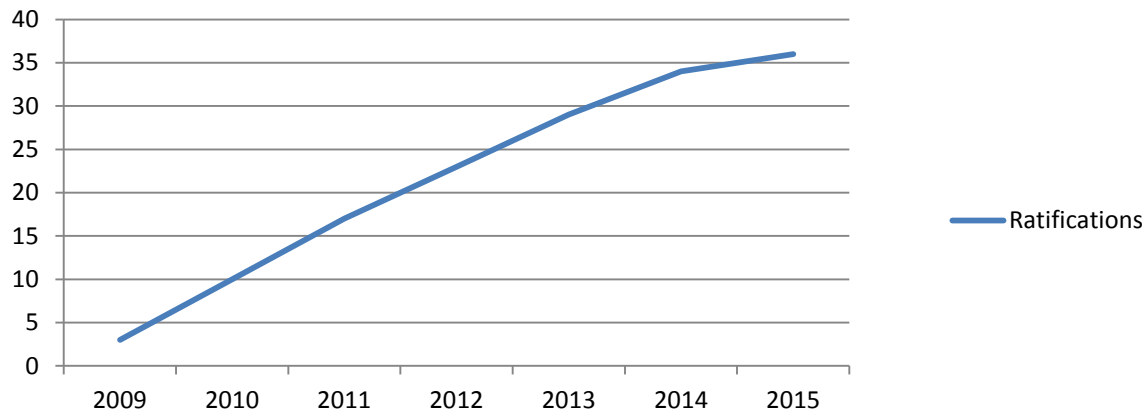

Ratifications of the Lanzarote Convention

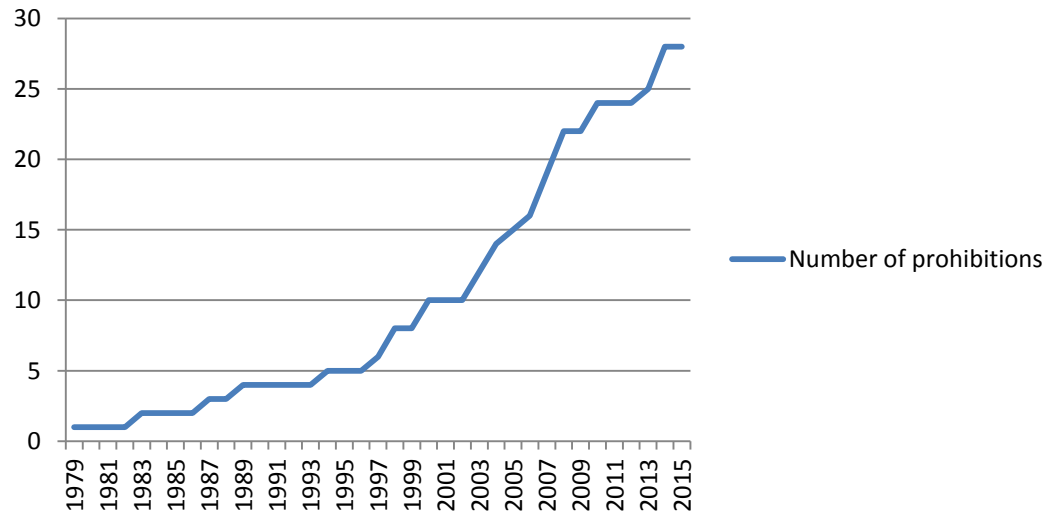

CoE member States having prohibited corporal punishment in the home

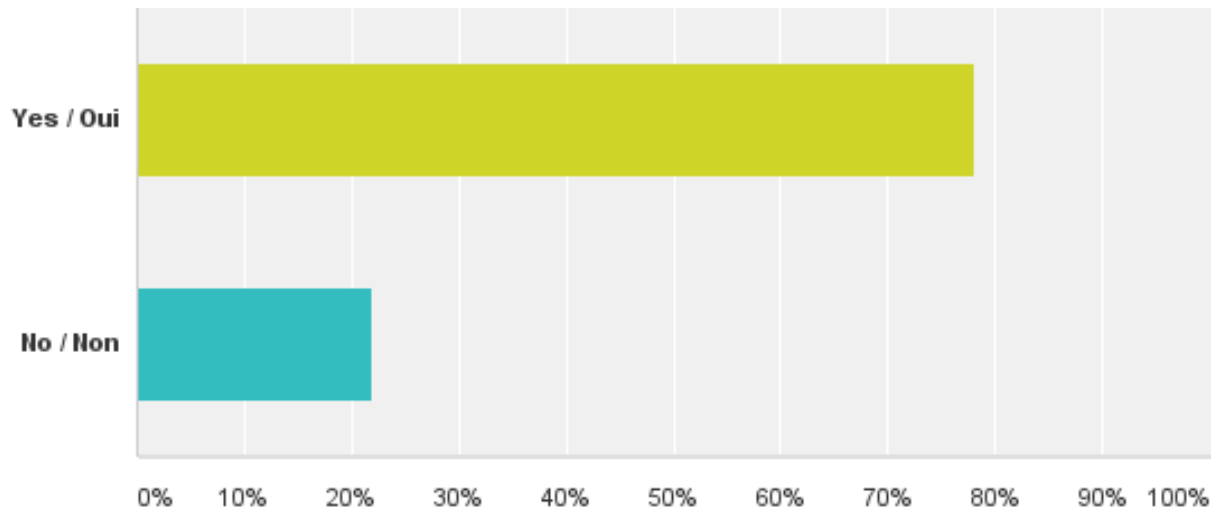

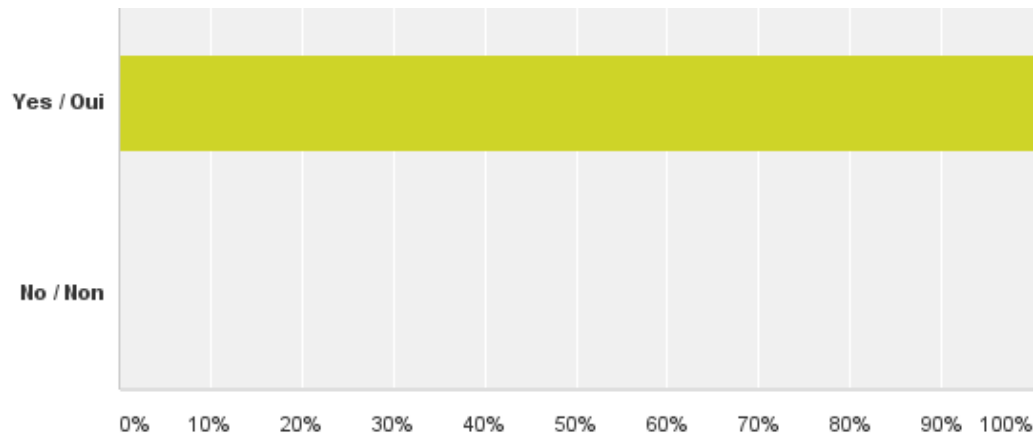

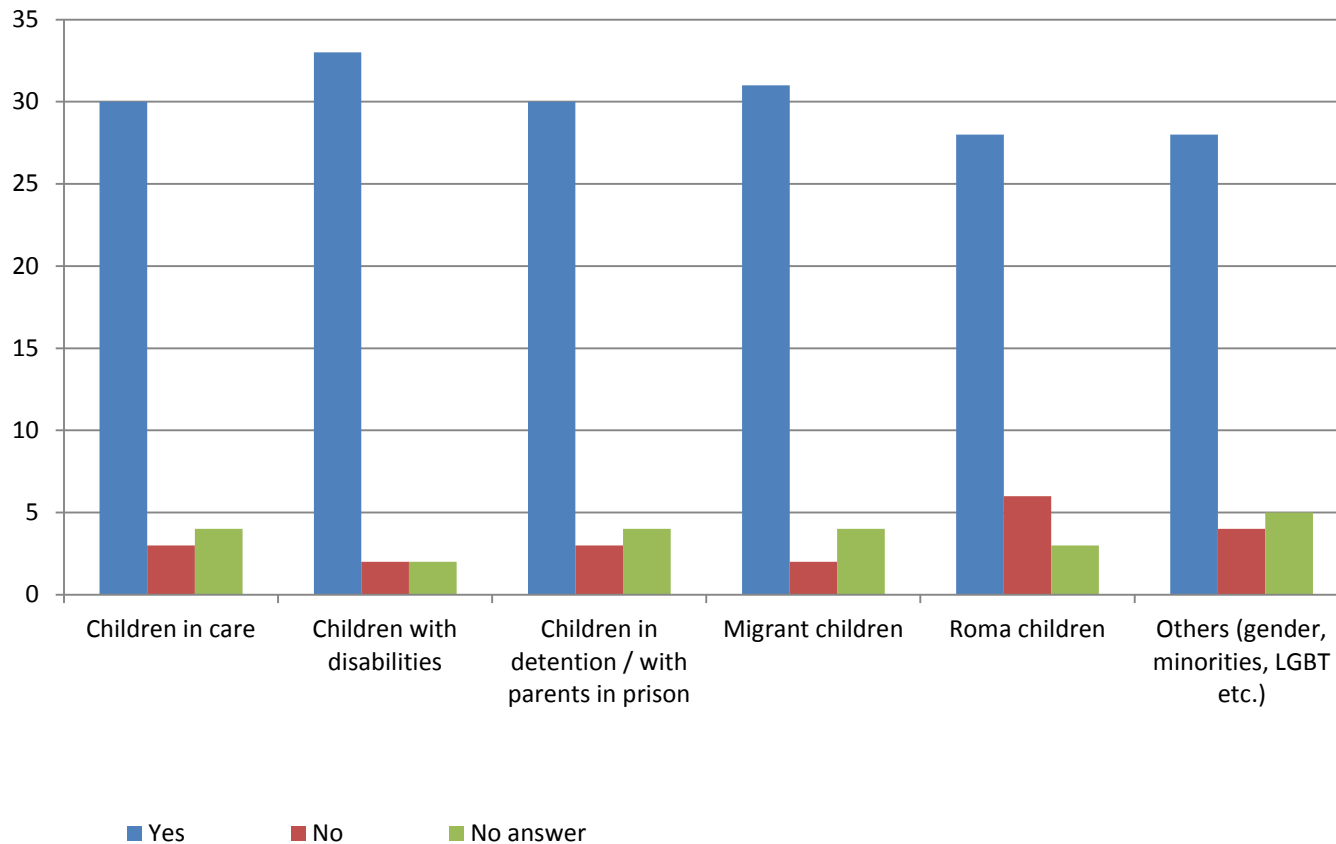

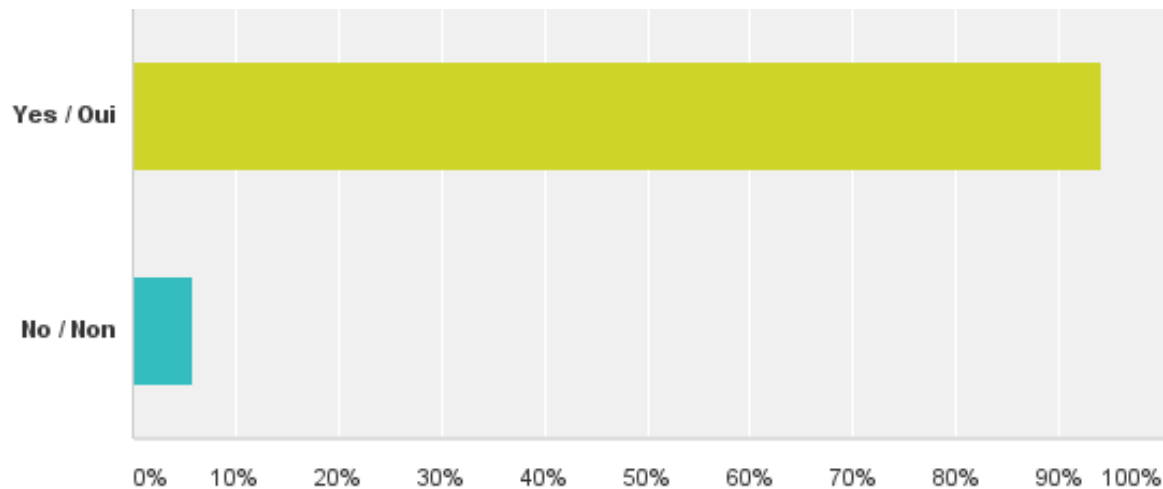
