## **Accessibility**

- aim: integration into society + live independently
- problem: architectural barriers + obstacles
- proposed solutions: training of decision-makers, raising awareness, changing attitudes





## **Accessibility**

Accessibility: principles and guidelines. Adaptation of buildings in an accessible built environment (1993)

- concepts: "integrated accessibility / design",
   "building for everyone"
- tools: "accessibility chart", "accessibility chain", training of architects





## Resolution ResAP(2001)1

Resolution ResAP(2001) 1 on the introduction of the principles of universal design into the curricula of all occupations working on the built environment ("Tomar Resolution") (15 Febr. 2001)

- aim: improve knowledge of professionals
- fields: higher education + vocational training
- proposed solution: compulsory learning modules





### Resolution ResAP(2001)1

#### new concepts:

- universal design principles
- "egressibility" (in background information)

#### method:

- user participation

# UN Convention on the Rights of Persons with Disabilities

Art. 11
Situations of risk and humanitarian emergencies

States Parties shall take, in accordance with their obligations under international law, including international humanitarian law and international human rights law, all necessary measures to ensure the protection and safety of persons with disabilities in situations of risk, including situations of armed conflict, humanitarian emergencies and the occurrence of natural disasters.
