IIIrd Ministerial Meeting

Ankara, 9-10 July 1991

The IIIrd Conference of Ministers of the Council of Europe's Open Partial Agreement on the prevention of, protection against and organisation of relief in the event of major natural and technological disasters took place in Ankara, 9-10 July 1991. (1)

1. The Ministers took note, with interest, of Turkish policy in the field of civil protection and European cooperation programmes being conducted in Turkey.
2. The Ministers congratulated the various European Centres of the Open Partial Agreement on the exhibition held on the occasion of their meeting.
3. The Minister noted with great interest:
 - the creation in Belgium of a European Centre under the Open Partial Agreement to deal with the legislative aspects of disasters, which should be of great legal assistance to Member States and other European Centres under the Agreement;
 - the creation in Aveiro (P) of a European Centre on major industrial disasters, and the holding of an international conference on this subject in Lisbon in 1992.
4. On a proposal by the Greek Minister, the Ministers of the Open Partial Agreement asked that the problem of the control of nuclear installations be put on the agenda of their next Meeting.
5. The Ministers adopted resolutions on the following themes:

organisation of this IIIrd Ministerial Meeting of the
Open Partial Agreement.

At the invitation of the Government of San Marino, the Ministers decided to hold their next meeting there, end 1992. At the Belgian Government's invitation, they agreed that the following one would be held in Belgium.

The Press Communique of their IIIrd Meeting (Appendix 2) was adopted.

RESOLUTION 4

EVALUATION OF THE EUROPEAN CENTRES OF THE OPEN PARTIAL AGREEMENT

The Ministers,

- aware of the importance of the programmes undertaken by the European Centres of the Open Partial Agreement on Major Disasters (see list in Appendix) in the fields of training, research, information and assistance and cooperation before, during and after a major disaster
- anxious to learn more about and encourage others to learn more about the projects and results of activities undertaken by the different European Centres
- considering the proposal by the French delegation to initiate a series of European Centre evaluations

PROPOSE that, to begin with, in 1992

- . a working session be organised on the occasion of the meeting of Chairmen and Directors of Centres, in order to determine guidelines for the European Centres' activity assessment procedure and consider the general working policy of the Open Partial Agreement;
- . this process of information and assessment relating to the European Centres of the Open Partial Agreement begin, in 1992, with invitations to a Permanent Correspondent and one or two advisers to attend a session of the scientific council of each European Centre;
- . the Permanent Correspondents be asked to draft reports, at their Committee meeting late in 1992, on the European Centres visited; the Committee will then decide whether or not to continue with the information and assessment process.
