#### **BACKGROUND INFORMATION FOR THE AGENDA**

#### Important note

Please note that active discussion between participants is considered the most beneficial aspect of this workshop. Participants are, therefore, strongly encouraged to come prepared to:

- discuss and share specific national experiences,
- identify needs and areas of possible improvement,
- consider ways of better co-ordination of international activities on Animal Welfare,
- assist in development and agreement of a joint CoE/EU/OIE Declaration prior to the conclusions of the meeting.

## **Opening**

The workshop will be opened by the representatives of the CoE, EU and OIE.

## **Introductory Session**

In the introductory session, the representatives of CoE, EU and OIE will present state of affairs and future perspectives in developing and promoting animal welfare. These contributions will include reflections on ethical, scientific, cultural and socio-economic principles used by each partner, the methods and means of standard setting, use of a democratic process and search of transparency, the handling of the conflict between science, technical advice and practical implementation.

In order to facilitate discussions within time constraints, each keynote speaker will have up to 15 minutes to present, but all are encouraged to provide more detailed written remarks which can be provided to all participants, to allow questions and comments from the floor. Power Point presentations are welcome.

During discussions the statements of participants, in particular stakeholders, on the endorsement of the work of the international organisations are welcomed.

The Moderator of the Introductory Session will present the draft of joint CoE/EU/OIE Declaration. This draft will be circulated in view of its discussion in plenary session on 24 November.

The representative of TAIEX (Unit of Directorate-General Enlargement of the European Commission) will present short-term technical assistance activities conducted by TAIEX in New Member States, acceding countries, candidate countries, and the administrations of the Western Balkans. TAIEX assistance is also provided to those countries included in the EU's European Neighbourhood Policy, as well as Russia.

## **Working Group Activities**

The aim of the discussions in working groups is to elucidate and share best practices and to determine its implementation in the field. Please refer to the attached list of groups.

The working groups will be called upon to analyse implementation of national and international rules on animal welfare in transport and slaughter, to identify obstacles in implementation of animal welfare rules (ethical, social, scientific and legal barriers) and their solutions, and to identify best practices and advantages of implementation of animal welfare rules.

To that end, delegations are invited to submit information (preferably before the meeting) on the basis of the questionnaire hereafter. The information in the questionnaire will be used to facilitate the group discussions and if appropriate will also be used to form the published summary of the conference. The questionnaire is looking at an overview of animal welfare legislation and implementation rather than requiring specific details except when necessary to explain best practice.

The elected co-ordinators of each group will make a summary of their activities in plenary (5 minutes for each presentation). Observer organisations are free to choose any Working Group.

Moreover, special thought will be given to the draft joint CoE/EU/OIE Declaration and participants will be invited to comment on and develop the document.

#### **Conclusions**

Before formally closing the workshop by the representatives of the CoE, EU and OIE, a joint CoE/EU/OIE Declaration will be formally adopted. The participants will be also invited to take a decision on the follow-up.
